The list of proposed candidates should be deliver to the Embassy of the Republic of Serbia in Tehran. The Embassy of the Republic of Serbia in Tehran can also proposes a candidate who is not on the list of the relevant institution of the Islamic Republic of Iran regarding of it estimation. The Embassy of the Republic of Serbia in Tehran should deliver the final list of proposed candidates to the Serbian Ministry of Foreign Affairs till July 4, 2025.

The Embassy has to honor to transfer also the following:

- The number of the proposed candidates should be in the frame of the given quota;
- The final day for registration delivery is June 25, 2025.

1. Introduction

The "World in Serbia" project, through which the Government of the Republic of Serbia awards scholarships to candidates from member states and observer states of the Non-Aligned Movement (NAM) (hereinafter referred to as NAM), has been successfully implemented since the 2010/2011 academic year.

Thanks to this project, the Republic of Serbia has the honour of hosting young people from 127 countries in Africa, Asia, and Central and South America. The traditional hospitality of our people, the helpfulness and responsible approach of professors and staff at student accommodation institutions, have enabled the scholarship recipients from all over the world to feel welcome and adjust to life in the Republic of Serbia.

The "World in Serbia" project provides excellent conditions, offering scholarship recipients accommodation and meals within the student support system of the Republic of Serbia, health insurance, and a financial scholarship of RSD 18,000 per month. These scholarship conditions, along with the warm reception the scholarship recipients received, have undoubtedly contributed to the immense interest among NAM member states and observer states in the new scholarships.

In all bilateral discussions held by representatives of the Republic of Serbia with representatives of NAM member states and observer states, satisfaction with the current cooperation within the Project has been emphasised, along with a strong interest in continuing the collaboration, including with countries that have not yet nominated their students.

In order to promote the Republic of Serbia and its culture, traditions, higher education, and policy of good cooperative relations and mutual respect in NAM member and observer states, the Republic of Serbia will use the "World in Serbia" project to offer new scholarships for learning the Serbian language in the 2025/2026 academic year, and subsequently for enrolment at higher education institutions in the Republic of Serbia in the 2026/2027 academic year.

The specific objectives of the "World in Serbia" project are as follows:

1. Providing young people from different cultures with the opportunity to get to know the Republic of Serbia, its language, culture, and traditions.
2. Offering young people from the Republic of Serbia the opportunity to meet colleagues from different continents, learn about their cultures, values, and traditions.
3. Affirming the Republic of Serbia as a country and its higher education system through scholarship recipients – future promoters of professional connections between our country and their home countries.

2. Project Partners

The implementation of the Project is managed by the Ministry of Education of the Republic of Serbia. A representative from the Ministry of Education is appointed to coordinate the implementation of the Project. In addition to the Ministry of Education, the following institutions also participate in the implementation of the Project: the Ministry of Foreign Affairs, the Ministry of Internal Affairs, the Ministry of Health, and the Qualifications Agency of the Republic of Serbia, in accordance with the law, as well as the universities of the Republic of Serbia and other institutions according to the needs of the students.

3. Project Description

3.1 Project Implementation Phases

The Project provides scholarships for citizens of member states and observer states of the Non-Aligned Movement (NAM) proposed by the governments of their respective countries and is implemented in two phases:

Phase one: Upon arrival in the Republic of Serbia, scholarship recipients undergo intensive Serbian language courses from September to June. Project scholarship recipients who already know Serbian, having completed the previous level of study in the Republic of Serbia, do not attend the language course but instead take an entrance exam at their desired higher education institution for the next level of study, for enrolment in the 2025/2026 academic year.

Project scholarship recipients who complete the Serbian language course and pass the Serbian language exam will take the entrance exam in the June enrolment period and enrol in their desired studies in the 2026/2027 academic year. If they are not admitted to their desired higher education institution, the scholarship recipients have the opportunity to take the entrance exam in subsequent enrolment periods at higher education institutions where places are still available.

During the Serbian language learning process, scholarship recipients will be provided with preparatory lessons for admission to their desired higher education institution.

The Project also ensures support for scholarship recipients, starting from their reception at the airport, their arrival in the country, and continuing with assistance in handling all administrative, organizational, and other needs throughout their stay in the Republic of Serbia.

Phase two: Scholarship recipients are to pursue studies according to their interests, in line with the offered study programmes in the Serbian language, with the possibility of consultations in English at higher education institutions founded by the Republic of Serbia. These institutions include the University of Belgrade, the University of Novi Sad, the University of Kragujevac, and

the University of Niš, as well as the academies of applied studies and colleges of applied studies, which are also founded by the Republic of Serbia.

The signing of a Scholarship Agreement with the recipients is also envisaged

3.2 Scholarship Structure within the Project

The scholarship within the Project includes:

- Free preparatory Serbian language instruction (intensive Serbian language course upon arrival in the Republic of Serbia). This does not apply to scholarship recipients who have already studied in Serbia and attended Serbian language classes.
- Free education within one level of studies, including undergraduate academic, integrated academic, and vocational studies, specialist vocational studies, master's academic and vocational studies, specialist academic or doctoral studies.
- A monthly scholarship in the amount of RSD 18,000.00.
- Free accommodation and meals at student standard institutions.
- Voluntary healthcare insurance for scholarship recipients studying the Serbian language.
- Mandatory healthcare insurance for scholarship recipients under 26 years of age, and voluntary healthcare insurance for scholarship recipients over 26 years of age.
- According to the Law on State Administrative Fees, No. 37, foreign nationals who are scholarship recipients of the Government and stay in the Republic of Serbia for the purpose of education or study are exempt from the residence fee, but are not exempt from paying additional fees necessary for processing residence permit applications (administrative fees for submission (RSD 400), issuance of temporary residence permit (RSD 2,040), and foreigner's temporary residence permit form (RSD 1,788)).
- Free recognition of secondary school diplomas.
- Free recognition of higher education diplomas.

The scholarship within the Project does not include:

- Travel expenses for arrival and departure from and to the Republic of Serbia;
- Public transportation costs within the Republic of Serbia;
- Costs for textbooks and study materials during the studies.

3.3 Conditions for Receiving a Scholarship

A candidate may be eligible for a scholarship if they meet the following conditions:

- They are a citizen of a member state or observer state of the Non-Aligned Movement (NAM).
- They have been proposed by the competent authority of the participating state in the Project.
- They are younger than:
 - 21 years old for enrolment in first-level studies – undergraduate academic studies, integrated academic studies, undergraduate vocational studies;
 - 25 years old for enrolment in first-level specialist vocational studies and second-level studies – master's academic studies, master's vocational studies, specialist academic studies;
 - 35 years old for enrolment in third-level studies – doctoral academic studies.
- They possess the appropriate educational qualifications:
 - For enrolment in undergraduate academic/integrated/vocational studies – they must have completed secondary education of **four years' duration**;
 - For enrolment in master's academic studies:
 - ✓ With 60 ECTS credits – they must have an appropriate diploma from a higher education institution obtained from undergraduate academic studies with at least 240 ECTS credits, or an appropriate diploma from a higher education institution of **four years' duration**;
 - ✓ With 120 ECTS credits – they must have an appropriate diploma from a higher education institution obtained from undergraduate academic studies with at least 180 ECTS credits;
 - For enrolment in specialist vocational studies – they must have an appropriate diploma from a higher education institution obtained from undergraduate academic or vocational studies with at least 180 ECTS credits;
 - For enrolment in master's vocational studies – they must have an appropriate diploma from a higher education institution obtained from undergraduate or specialist vocational studies, or undergraduate academic studies, with at least 180 ECTS credits;
 - For enrolment in doctoral academic studies – they must have completed undergraduate academic and master's academic studies, or integrated studies, with an overall average grade of at least 8 in both undergraduate academic and master's academic studies, or integrated studies.
- Knowledge of English at least at A1 level, or knowledge of Serbian at least at A1 level upon arrival.

3.4 Documentation for Application

Documentation to be submitted by the candidate when applying:

- Curriculum Vitae with a motivational letter;
- Copy of the travel document (passport) – not translated;
- Proof of acquired education – transcripts of educational qualifications certified by an authorized person (secondary school certificates, diploma of completed secondary education – for enrolment in undergraduate studies, higher education diplomas – for enrolment in master's studies, higher education and master's diplomas – for enrolment in doctoral studies, and transcripts for both study levels and diploma supplements);
- Certificate of the average grade from the previous level of studies for enrolment in doctoral studies;
- Proof of proficiency in English or Serbian at a conversational level (certificate, attestation, confirmation, etc.);
- Health certificate not older than 6 months – submitted with the application – obtained from the competent diplomatic-consular mission of the Republic of Serbia.

3.5 Application Deadline

The deadline for submitting application forms with supporting documentation is no later than **1st June 2025**. Documentation that is not translated into English or Serbian will not be considered.

Candidates should submit their applications via the link https://bit.ly/World_in_Serbia, and send the scanned original documentation, as well as translations into Serbian or English certified by an authorized person, to the email address worldinserbia@prosveta.gov.rs.

A copy of the original documentation, along with the completed and signed application form and a copy of the health certificate with the required test results, should be submitted to the relevant institution in the candidate's country, which has announced the scholarship competition under the "World in Serbia" project.

The list of proposed candidates for the "World in Serbia" project scholarships should be submitted by the candidate's country's relevant institution to the competent diplomatic-consular mission of the Republic of Serbia. The relevant diplomatic-consular mission of the Republic of Serbia may propose a candidate not on the list of the candidate's country's institution, based on their assessment.

The competent diplomatic-consular mission of the Republic of Serbia will forward the list of proposed candidates to the Ministry of Foreign Affairs of the Republic of Serbia, which, after reviewing it, will send it to the Ministry of Education of the Republic of Serbia.

3.6 Obligations of the Project Scholarship Recipient

The scholarship recipient is obligated to:

- Arrive in Belgrade between September 1 and September 15;
- Bring original documents (secondary school certificates, diplomas of higher education, master's diplomas, transcripts, and diploma supplements), translated into Serbian or English, upon arrival in the Republic of Serbia;
- Bring an original health certificate with required test results in Serbian/English, no older than six months;
- Undergo a mandatory general medical examination upon entering the student services institution;
- Pass a Serbian language exam before starting studies at higher education institutions in the Republic of Serbia;
- Pass the entrance exam at the chosen faculty and completes the enrolment;
- Regularly attend classes and take exams;
- Earn 37 ECTS credits during the current academic year for enrolment in the next year of study, within the enrolled study programme for the academic year, or in the case of scholarship recipients in doctoral studies, considering that exams, research seminars, scientific research papers, and dissertations carry a certain number of ECTS credits, the scholarship recipient is obliged to:
 - Pass the exams required by the study programme for the specific year of study;
 - Provide confirmation that research topics, research seminars, etc., outlined in the study programme, have been approved for them;
 - Provide confirmation that the topic of their doctoral dissertation has been submitted and approved, or that their doctoral dissertation topic has been approved.
- respect the laws of the Republic of Serbia and the regulations of the higher education institution where the scholarship is being awarded;
- compensate for any damage caused within the premises of the student accommodation facilities and the higher education institution;
- Adhere to the code of conduct prescribed by the statute of the higher education institution;
- Follow the rules of conduct and house rules at the student accommodation facility;
- Regulate their temporary stay and submit a timely request for its extension when conditions for that are met, in accordance with the provisions of the Law on Foreigners ("Official Gazette of the RS," Nos. 24/2018, 31/2019, and 62/2023);

- Inform the Ministry of Education of any changes that may affect their status as a scholarship recipient under the Project, in a timely manner, and no later than 30 days from the occurrence of such changes (e.g., loss of student status, suspension of rights and obligations related to student status, withdrawal from studies, etc.);
- Return to the country that nominated them for the scholarship under the Project upon completion of their studies.

Scholarship recipients on doctoral studies are obliged to:

- Pass the exams prescribed by the study programme for the respective year of study;
- Provide confirmation that the topics for research papers, research seminars, etc., as outlined in the study programme, have been approved;
- Provide confirmation that they have submitted a doctoral dissertation topic or that their dissertation topic has been approved (considering that exams, research seminars, scientific research papers, and the dissertation carry a certain number of ECTS credits).

3.7 Reasons for Losing the Scholarship

A scholarship recipient loses their scholarship if they:

- submit documentation during the scholarship application process that is not authentic;
- fail to pass the Serbian language exam with at least a passing grade;
- candidates who have completed the previous level of studies in the Republic of Serbia within the Project, who have been granted a scholarship for enrolling in a new level of studies, and fail to pass the entrance exam in the first or second admission period for the 2025/2026 academic year;
- a scholarship recipient studying the Serbian language from September 2025 to June 2026 does not enrol in studies at a higher education institution in the Republic of Serbia for the 2026/2027 academic year;
- in undergraduate, master's, and doctoral studies, fail to obtain 37 ECTS credits required for enrolling in the next academic year, as a student financed from the budget within the Project, in accordance with the general act of the higher education institution that defines the conditions for enrolment in the next year;
- complete the level of studies for which they were granted a scholarship based on their application for the competition;
- violate the provisions of the Scholarship Agreement.

- fail to inform the Ministry of Education in a timely manner, and no later than 30 days, about any changes that affect their status as a scholarship recipient within the Project (e.g., loss of student status, suspension of rights and obligations, withdrawal from studies, etc.);
- commit a serious breach of student obligations, as outlined in the general act of the higher education institution and the student services institution, in accordance with the law;
- disturb public order and peace;
- are sentenced to imprisonment for a period of at least six months, either on probation or with a stricter penalty;
- behave inappropriately or grossly violate the rules of study as prescribed by the statutes of the higher education institution and the student services institution;
- voluntarily withdraw from the scholarship.

In addition, a scholarship recipient enrolled in doctoral studies loses their scholarship if they:

- fail to earn the 37 ECTS credits required for enrolling in the next academic year;
- fail to pass the remaining exams in the following academic year;
- fail to provide confirmation that the topics for their scientific research papers, research seminars, etc., have been approved as part of their study programme;
- fail to provide confirmation that they have registered their doctoral thesis topic or that their thesis topic has been approved;
- fail to defend their doctoral thesis within the legal timeframe.

3.8 General Provisions for Studying within the Project

Under the Project, a scholarship recipient may only pursue one study programme within a single cycle of studies.

The student is required to earn 37 ECTS credits in the academic year within the enrolled study programme, which are necessary for enrolling in the following year of studies as a student funded by the Project budget, in accordance with the general regulations of the higher education institution, which set the conditions for enrolment in the next academic year.

A scholarship recipient who has earned at least 37 ECTS credits in each academic year will retain their scholarship for one more academic year upon completing the final year of their study programme, until they finish their ongoing studies.

For students who have completed their chosen level of studies but need to complete an internship or professional practice for diploma recognition, the scholarship may be extended to cover free accommodation, meals, health insurance, and a monthly scholarship of RSD 18,000.

provided they submit confirmation that they are volunteers and not employed during the internship period.

Students who have lost their scholarship can regain their status as scholarship recipients only in the following academic year, provided they earn 37 ECTS credits during the current academic year.

A scholarship recipient must attend the enrolled study programme. Transferring to another study programme within the Project is not allowed.

Upon completion of the study level for which the scholarship recipient applied, if they wish to continue to a higher level of study, they can do so by applying to a new scholarship competition.

A scholarship recipient who is unable to earn the required number of ECTS credits for enrolment in the next academic year due to a serious illness during the current academic year has the right to re-enrol in the same year of studies, with proof of suspension of student rights and obligations, and retain their scholarship. The scholarship recipient must submit the complete medical documentation (with confirmation from the medical institution's medical board, stating that it is a serious illness) to the higher education institution and the Ministry of Education by the end of the current academic year, or no later than 30 September, along with proof of the suspension of student rights and obligations.

The scholarship recipient is obligated to pass the remaining exams during the repeated academic year and earn the necessary number of ECTS credits to enrol in the next academic year. If not, they lose the right to continue receiving the scholarship.

The scholarship holder must get information from the relevant authorities about their rights and obligations regarding the regulation of temporary residence in the Republic of Serbia.

Higher education institutions involved in the Project are obligated to provide the Ministry of Education with reports on the progress of scholarship students at least twice a year (within fifteen days of the end of the winter and summer semesters).

Higher education institutions involved in the Project are also required to inform the Ministry of Education in a timely manner, and no later than 30 days from the occurrence of any changes that affect the status of the scholarship recipient within the Project (graduation, withdrawal from studies, etc.).

4. Proposal and Selection of Candidates

Each country participating in the Project must nominate candidates proposed for scholarships within the Project. All registered candidates must meet the requirements for being awarded the scholarship.

The Ministry of Foreign Affairs shall submit the lists of proposed candidates to the Ministry of Education by no later than 10th June, along with the application forms of all registered candidates.

Following a formal verification of the submitted applications for the scholarship, the Minister responsible for education shall issue a decision to appoint a special interdepartmental commission that will review the documentation received from the Ministry of Foreign Affairs and select the proposed candidates. The commission will be composed of representatives from the Ministry of Education, the Ministry of Foreign Affairs, and the Qualifications Agency - ENIC/NARIC centre. This decision will outline the tasks of the commission for selecting candidates and awarding scholarships.

The decision regarding the final list of proposed candidates, made by the Minister responsible for education, will be sent by the Ministry of Education to the Ministry of Foreign Affairs by 26th June, for informing the embassies, as well as all the candidates who applied. The Ministry of Foreign Affairs is required to notify all embassies between 27th June and 4th July.

5. Expected Effects of Project Implementation

The successful implementation of the Project will enable the achievement of both short-term and long-term positive effects for the Republic of Serbia, namely:

- positioning the Republic of Serbia as a modern, open, and European country, with the contribution of the scholarship recipients as future leaders of the social, economic, and political life of their countries.
- improving and deepening friendly relations between young people from all over the world.
- introducing colleagues from different continents provides an opportunity for intercultural learning, familiarizing them with other cultures and values, and increasing their sensitivity to diversity;
- promoting the higher education system of the Republic of Serbia.
- promoting the cultural, scientific, economic, tourist, and other capacities of the Republic of Serbia.

for the award of scholarships within the framework of the "World in Serbia" Project for the 2024/2025 school year and for learning the Serbian language in the 2025/2026 school year and for enrollment in higher education institutions in the Republic of Serbia in the 2026/2027 school year

Scholarship structure

The scholarship within the Project includes:

- Free preparatory Serbian language instruction (intensive Serbian language course upon arrival in the Republic of Serbia). This does not apply to scholarship recipients who have already studied in Serbia and attended Serbian language classes.
- Free education within one level of studies, including undergraduate academic, integrated academic, and vocational studies, specialist vocational studies, master's academic and vocational studies, specialist academic or doctoral studies.
- A monthly scholarship in the amount of RSD 18,000.00.
- Free accommodation and meals at student standard institutions.
- Voluntary healthcare insurance for scholarship recipients studying the Serbian language.
- Mandatory healthcare insurance for scholarship recipients under 26 years of age, and voluntary healthcare insurance for scholarship recipients over 26 years of age.
- According to the Law on Administrative Fees, No. 37, foreign nationals who are scholarship recipients of the Government and stay in the Republic of Serbia for the purpose of education or study are exempt from the residence fee, but are not exempt from paying additional fees necessary for processing residence permit applications (administrative fees for submission (RSD 400), issuance of temporary residence permit (RSD 2,040), and foreigner's temporary residence permit form (RSD 1,788)).
- Free recognition of secondary school diplomas.
- Free recognition of higher education diplomas.

The scholarship within the Project **does not** include:

- Travel expenses for arrival and departure from and to the Republic of Serbia;
- Public transportation costs within the Republic of Serbia;
- Costs for textbooks and study materials during the studies.

Conditions for receiving a scholarship

A candidate may be eligible for a scholarship if they meet the following conditions:

- They are a citizen of a member state or observer state of the Non-Aligned Movement (NAM).
- They have been proposed by the competent authority of the participating state in the Project.
- They are younger than:
 - 21 years old for enrolment in first-level studies – undergraduate academic studies, integrated academic studies, undergraduate vocational studies;
 - 25 years old for enrolment in first-level specialist vocational studies and second-level studies – master's academic studies, master's vocational studies, specialist academic studies;
 - 35 years old for enrolment in third-level studies – doctoral academic studies.
- They possess the appropriate educational qualifications:
 - For enrolment in undergraduate academic/integrated/vocational studies – they must have completed secondary education of **four years' duration**;
 - For enrolment in master's academic studies:
 - With 60 ECTS credits – they must have an appropriate diploma from a higher education institution obtained from undergraduate academic studies with at least 240 ECTS credits, or an appropriate diploma from a higher education institution of **four years' duration**;
 - With 120 ECTS credits – they must have an appropriate diploma from a higher education institution obtained from undergraduate academic studies with at least 180 ECTS credits;
 - For enrolment in specialist vocational studies – they must have an appropriate diploma from a higher education institution obtained from undergraduate academic or vocational studies with at least 180 ECTS credits;
 - For enrolment in master's vocational studies – they must have an appropriate diploma from a higher education institution obtained from undergraduate or specialist vocational studies, or undergraduate academic studies, with at least 180 ECTS credits;
- For enrolment in doctoral academic studies – they must have completed undergraduate academic and master's academic studies, or integrated studies (at least 5 years of finished academic studies), with an overall average grade of at least 8.5 in both undergraduate academic and master's academic studies, or integrated studies of 300 ECTS credits.
- Knowledge of English at least at A1 level, or knowledge of Serbian at least at A1 level upon arrival.

How to apply

The above steps must be followed, otherwise the application will not be taken into consideration.

Step 1.

The candidate applies via the link https://bit.ly/World_in_Serbia.

Step 2.

The candidate shall submit scanned original documentation as well as translations into Serbian or English certified by an authorized person to the email address worldinserbia@praveta.gov.rs and be sure to include the name, surname and country of application in the subject line:

- CV (Curriculum Vitae) with motivation letter;
- photocopy of travel document (passport) - not translated;
- proof of acquired education - certified photocopies of documents (secondary school certificates, secondary school diplomas, higher education diplomas, master's diplomas, transcripts of grades and diploma supplements) transcripts, proof of acquired education certified by an authorized person;
- certificate of average grade from the previous level of studies;
- Proof of proficiency in English or Serbian at a conversational level (certificate, attestation, confirmation, etc.);
- Health certificate not older than 6 months - submitted with the application - obtained from the competent diplomatic-consular mission of the Republic of Serbia.

Step 3.

The candidate submits the following documents to the competent institution of his/her country that announced the application for scholarships within the "World in Serbia" project:

- confirmation of successful application at the link https://bit.ly/World_in_Serbia;
- CV with motivation letter;
- photocopy of travel document (passport);
- documentation as proof of acquired education - certified photocopies of documents (secondary school certificates, secondary school diplomas, higher education diplomas, master's diplomas, transcripts of grades and diploma supplements) transcripts, evidence of acquired education certified by an authorized person for the purpose of inspection and selection;
- certificate of average grade at the last level of studies;
- completed and signed application form
- a copy of the health certificate with the required test results, the form submitted with the application.

NOTE:

- Documentation of a candidate who has not applied via the link https://bit.ly/World_in_Serbia and has not submitted complete documentation translated into Serbian or English to the email worldinserbia@prosveta.gov.rs will not be taken into consideration;
- After passing the entrance exam and being admitted to a specific study program, the scholarship holder does not have the right to change the study program.

Application deadline

Deadline for candidate application via the link https://bit.ly/World_in_Serbia is no later than 25th May 2025, and the submission of the List of proposed candidates by the competent diplomatic and consular mission of the Republic of Serbia to the Ministry of Foreign Affairs of the Republic of Serbia is no later than June 1st, 2025.

Selected scholarship holders are required to bring upon arrival in the Republic of Serbia:

- original documents (secondary school certificates, higher education diplomas, master's diplomas, transcripts of grades and diploma supplements), translated into Serbian/English;
- certificate of average grade at the last level of studies;
- original health certificate with the required test results, in Serbian/English, not older than six months.

Other information related to the scholarship is described in detail in the Conclusion of the Government of the Republic of Serbia attached as well as in the Project Description.
